I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Compliance Verification Assessment (04/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 27/08/2015 submitted by the college authorities on the physical and other teaching facilities available at Government Medical College, Bhavnagar for Renewal of recognition of MD(Tuberculosis & Respiratory Diseases/Pulmonary Medicine) qualification for 01 seat under Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar and the Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment (04/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 27/08/2015 submitted by the college authorities and decided to recommend to the Central Government that the recognition of MD(Tuberculosis & Respiratory Diseases/Pulmonary Medicine) qualification for 01 seat granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
