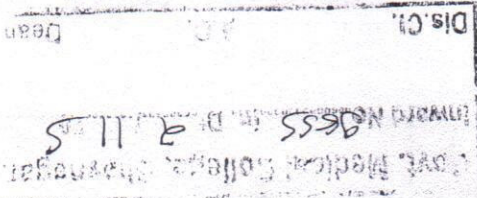
I am to state that the General Body of this Council at its meeting held on 01/10/2015 considered the Council Assessor's Report (April, 2015) on the physical and other teaching facilities available at Government Medical College, Bhavnagar for Renewal of recognition of MD(DVL) and DVL qualifications for 01 seat each under Maharashtra Krishnakumarsinghi Bhavnagar University, Bhavnagar and the Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend to the Central Government that recognition of MD(DVL) and DVL qualifications for 01 seat each granted by Maharashtra Krishnakumarsinghi Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
